## OPEN GYM GUIDELINES

1. You must provide office staff with a valid driver's license, state ID or Park ID for entrance to the gym. No exceptions will be made.
2. To obtain a Park ID, the parent/guardian of the applicant must be present and provide current picture ID to prove residency. Parent/guardian must fill out and sign a Chicago Ridge Park District Park ID application giving the Park District permission to take applicant's picture (for initial ID and all subsequent replacement IDs). Park ID's are made while you wait. *There is a \$5.00 fee for non-resident IDs and each replacement ID.* Signature is also required for acceptance of/adherence to Open Gym Guidelines.  
\*\*\*NOTE: ID will expire two (2) years from date of application. The process will need to be repeated for a new ID. The replacement fee of \$5.00 will be waived if expired ID is turned in to staff.
3. There is a two-hour limit on Open Gym. Should you desire to stay beyond the two-hour limit, you must pay for another session.
4. Participants will be instructed to leave the premises if they are found committing any of the following:
  - a. Cursing/Spitting on the floor
  - b. Obnoxious and un-sportsmanlike behavior
  - c. Mishandling Park equipment
  - d. Defacing Park property
  - e. Fighting
  - f. Behaving in any way the office staff deems inappropriate
5. If asked to leave, participants must do so immediately, or the office staff will be forced to phone the police.
6. The Park District reserves the right to suspend Open Gym privileges for a period of time deemed appropriate by Director. Parents/guardians of suspended individual will be notified by phone, or by mail if necessary.
7. To reinstate Open Gym privileges after suspension, the minor participant's parent/guardian must resubmit Park ID application according to instructions above on or after suspension is complete.
8. An Open Gym schedule is provided monthly. However, the Park District reserves the right to make updates at any time. It is suggested that you call ahead to make sure Open Gym time is available.
