

In consideration of being allowed to participate in any way in the WickedBall Chicago Bubble Ball, Bubble Soccer program, or Wicked Archery program of Wicked Entertainment LLC, WickedBall Incorporated, Wicked Archery Inc (collectively "Wickedball"), related events and activities, the undersigned acknowledges and agrees that:

1)The risk of injury from the activities involved in this program is significant, including the potential for permanent disability and death, and while particular rules, equipment, and personal discipline may reduce this risk, the risk of serious injury does exist; and,

2)Specifically, I understand the following activities may result in the following corresponding injuries:

- a)WickedBall bubble soccer - Competing in American soccer, encapsulated inside a giant bubble ball. Players are trying to score goals, but as part of the game, are bumping into each other with impact. Accordingly, possible injuries include sprained ankle, wrist, concussion, bruising, cuts, nausea, dizziness, fatigue, and broken bones,
- b)Wicked Archery - Players are playing a dodgeball type game. Players wear protective face mask, and shoot foam arrows with bows at the opposing team to win the game by knocking out all enemy players, or targets on the field. Accordingly, possible injuries include sprained ankle, wrist, concussion, bruising, cuts, nausea, dizziness, fatigue, and broken bones.
- c)Dodgeball - Players compete by throwing rubber balls at each other in an arena until only one team is left standing. If a player is hit by a ball, they are out of the game. Accordingly, possible injuries include sprained ankle, wrist, concussion, bruising, cuts, nausea, dizziness, fatigue, and broken bones.
- d)Nerf Battle - Players are playing a Dodgeball type game. Players wear protective face mask and shoot foam balls at the opposing team to win the game by knocking out all enemy players, or targets on the field. Accordingly, possible injuries include sprained ankle, wrist, concussion, bruising, cuts, nausea, dizziness, fatigue, and broken bones.
- e)Gaming area - Players have the ability to play table games such as foosball, basketball, air hockey, table tennis, video games. Accordingly, possible injuries include sprained ankle, wrist, concussion, bruising, cuts, nausea, dizziness, fatigue, and broken bones,

3)I KNOWINGLY AND FREELY ASSUME ALL SUCH RISKS, both known and reasonably foreseeable, EVEN IF ARISING FROM THE NEGLIGENCE OF THE RELEASEES or others, and assume full responsibility for my participation; and,

- 4) I certify that I am in sound health for vigorous physical activity, am not pregnant, and have valid medical or health insurance coverage in effect at this time, and there is no reason why I cannot participate in this athletic program; and
- 5) I willingly agree to comply with the stated and customary terms and conditions for participation. If, however, I observe any unusual significant hazard during my presence or participation, I will remove myself from participation and bring such to the attention of a program leader immediately; and,
- 6) I RELEASE AND HOLD HARMLESS WickedBall Chicago, Wicked Entertainment LLC, Wicked Archery, Inc, Brandon Vidmar, program leaders, assistant volunteers, or employees, other participants, sponsoring agencies, sponsors, advertisers, and if applicable, owners and lessors of premises used to conduct the event (“RELEASEES”), WITH RESPECT TO ANY AND ALL INJURY, DISABILITY, DEATH, or loss or damage to person or property, WHETHER ARISING FROM THE NEGLIGENCE OF THE RELEASEES OR OTHERWISE, to the fullest extent permitted by law. Such release applies to whether Wickedball’s services are rendered offsite or on Wickedball’s premises ; and,
- 7) In the event that Wickedball is found liable for participant’s injury, participant’s damages shall be limited to compensatory damages.
- 8) I consent to WickedBall and their representatives taking photographs or digital recordings of me as a participant during this event and use these in any and all media for training or promotional purposes. I waive any rights, claims or interest and I understand that there will be no financial or other remuneration.
- 9) I agree that if I damage any property of WickedBall, including but not limited to - Camera's, Camcorders, Bubble Balls, Nets, and pumps, due to negligence, sharp objects on my person, or running into a sharp object that can puncture a bubble ball, I can be held responsible and charged for the cost of the damaged property. Intentionally damaging the equipment, not following the rules of the game, safety rules, or WickedBall Staff members, will result in immediate charge of the equipment damaged.
